For example, if the market is going down at a time, then it might pull down the prices of even some good stocks. Moreover, in the short term, market risks are higher compared to the long term.
- IV. Economy risk: The country's economy plays a vital role in the performance of financial instruments. The economic risk includes growth of the country, inflation, interest rates, the balance of payment etc.
